DISCUSSION AND CONSIDERATION BY THE TOWN BOARD: BUDGET WORK SESSION

DISCUSSION AND CONSIDERATION BY THE TOWN BOARD: SIMMON DRIVE PARTNERSHIP WITH VILLAGE OF OSCEOLA At the October 4, 2021 Town Board of Supervisors meeting, Ben Krumenauer, Village Administrator, gave an update on the proposed 2022 capital improvements to Simmon Drive, which is a shared boundary road between the Village of Osceola and the Town of Osceola. The new proposal has a projected total cost of \$581,373.69 with LRIP Grant up to 50% of the joint reconstructive effort's cost.

The Board discussed a proposed offer to Village of Osceola which represents greater than a 20% increase over what the Town of Osceola is realistically responsible for and the Village of Osceola is free to reconstruct the Simmon Drive to whatever additional improved standards they desire or see fit.

MOTION BY GUSTAFSON/EVERSON THAT THE TOWN OF OSCEOLA OFFERS THE VILLAGE OF OSCEOLA \$16,090.92 TOWARDS THEIR PROPOSED SIMMON DRIVE RECONSTRUCTION PROJECT, PAID UPON COMPLETION AND CONTINGENT UPON IT BEING RECONSTRUCTED TO AT LEAST MINIMUM TOWN OF OSCEOLA SPECIFICATIONS. A LETTER WAS DRAFTED AND SIGNED BY ALL BOARD MEMBERS AND SENT TO BEN KRUMENAUER, VILLAGE ADMINISTRATOR, VILLAGE OF OSCEOLA EXPLAINING THE PROPOSED PAYMENT AMOUNT. MOTION CARRIED.
