2. ROLL CALL MIKE, BRANDON , AND DOUG PRESENT.
3. MADE CHANGES TO August 4<sup>TH</sup> MEETING MINUTES MOTION DOUG, MIKE SECOND MIKE, TO ACCEPT, PASSED ALL.
4. ACCEPT AGENDA, MOVED TO ALLOW LINE ITEM 11 BULLET POINT C TO FIRST DISCUSSION PASSED ALL.
